Notes:

- There are two forms for authorising an agent (Form 39a and Form 39b) to submit allocation trades. Care should be taken to choose the right one for your situation.
 - Form 39a rescinds all previous authorisations and is used to appoint agent(s) who is /are recorded in the register and continue to be agent(s) until the authorisation is withdrawn.
 - This form, Form 39b appoints an agent for a particular trade - this is not recorded in the register and the completed Form 39b must be submitted with the trade application.
- This form may be used to appoint as agents any persons to act individually on behalf of all the holders.
- Agents may sign and submit "Application to Trade Water Allocations", on behalf of the holders of an ABA, subject to the conditions specified on the form.
- Agents may not cancel or withdraw an application to trade allocation once it has been lodged. Please refer to Form 39 explanatory notes on 'Withdrawal of application to trade water allocation' and contact your water corporation if you require further information.
- ABA holders who wish to authorise an agent or agents on an ongoing basis and to have the authorisation recorded in the water register should not complete this form but instead use Form 39a.
- Agent(s) who is/are recorded in the water register as an authorised agent may appoint another agent using this form.
- If there is insufficient space to nominate all authorised agents or ABA holders, please attach another application form.
- This authorisation applies only under the conditions as specified on this form.
